- Apply knowledge and proficiency of various thermal techniques, including hair pressing, blow-drying, and flat ironing

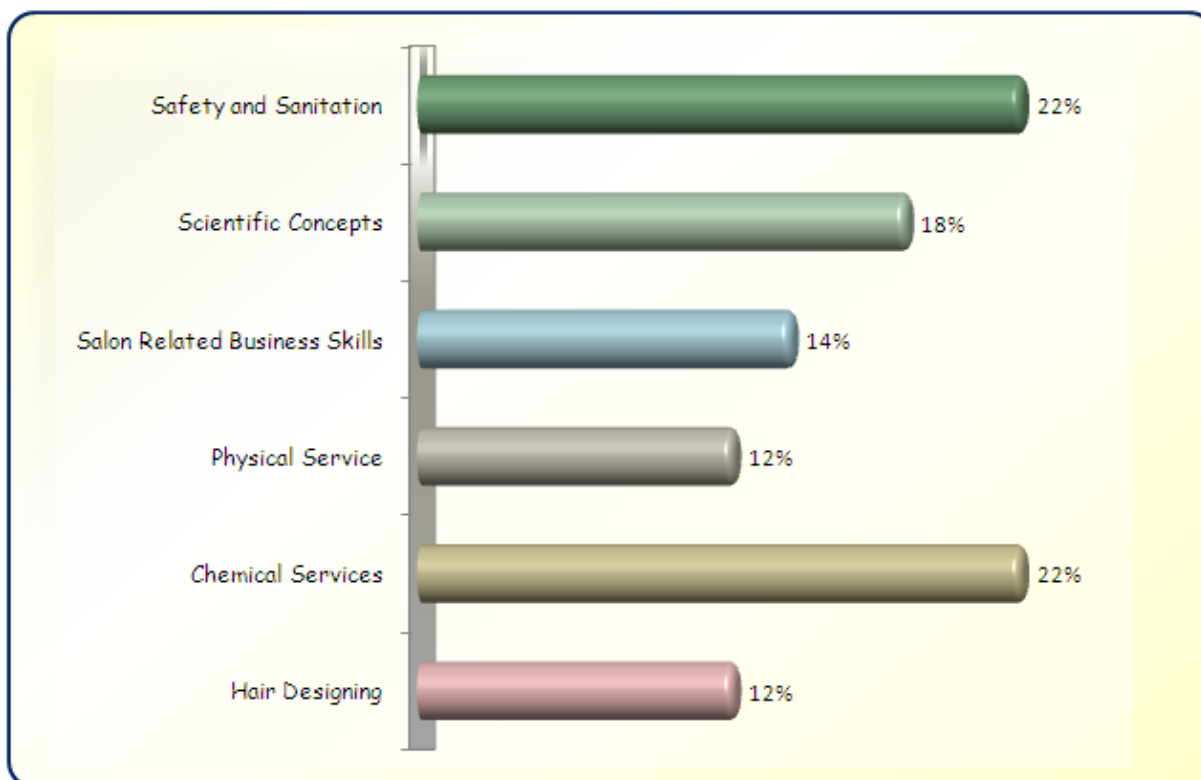

### Areas Covered:

#### 19% 90-Degree Haircut

Materials and implements are clean and sanitary, use appropriate draping for mannequin (neck strip or towel), haircut techniques, texturizing, implement handling, properly dispose of cut hair, and time to complete Job 1.

#### 23% Blow Dry, Curl, and Press Hair

Materials and implements are clean and sanitary, mannequin properly draped (neck strip or towel), blow-dry technique, pressing comb technique, flat iron technique, Marcel iron technique, workstation left in clean and orderly condition, and time to complete Job 2.

#### 28% Chemical Applications

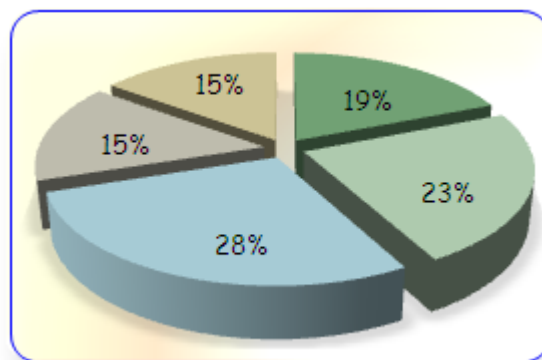
Materials and implements are clean and sanitary, mannequin properly draped for chemical service, section hair into four uniform working areas and properly secure sections, wear protective gloves during application of chemical service, tint retouch technique (hair section A), foil highlight techniques (hair section B), first-time relaxer techniques (hair section C), permanent waving technique (hair section D), workstation left in clean and orderly condition, and time to complete Job 3.

#### 15% Manicure

Sanitize table, hands, and model's or mannequin's hands before manicure service, materials and implements are clean and sanitary, manicure technique, workstation left in clean and orderly condition, and time to complete Job 4.

#### 15% Facial

Sanitize table and hands before facial service, materials and implements are clean and sanitary, mannequin properly draped (including hair covering), facial technique, workstation left in clean and orderly condition, and time to complete Job 5.



**Sample Job:** Manicure

**Maximum Time:** 20 minutes

**Participant Activity:** The participant will sanitize a manicure table and arrange supplies and implements, perform a full manicure including a hand massage, remove excess cream from nails, and polish nails with 1 base coat, 2 coats of dark polish and 1 top coat.
