2023 NCATC Innovative ATC Workforce Development Award Recipient Announced

BIG RAPIDS, MI – The National Coalition of Advanced Technology Centers (NCATC), NOCTI, and Nocti Business Solutions (NBS) are pleased to announce Mr. Dan Stroot of Missouri as this year's recipient of the NCATC Innovative ATC Workforce Development award. The NCATC Innovative ATC Workforce Development Award recognizes outstanding workforce development professionals and industry colleagues who make significant contributions to the education and training of today's advanced technology and manufacturing workforce.

Mr. Dan Stroot serves as a senior manager at The Boeing Company, located in St. Louis, Missouri. Since 2007, St. Louis Community College's Workforce Solutions Group and The Boeing Company have partnered to offer a pre-employment program focused on preparing individuals with the skills and knowledge to become future Boeing employees. Upon completion of the training program, graduates are guaranteed to receive an opportunity to interview with Boeing and receive nine credit hours for participating in the course. Understanding the importance of building the pipeline for the aerospace industry, Mr. Stroot also assisted in developing complementary activities to be offered at high schools and CTE schools. These activities are designed to spark interest in aerospace and encourage students to focus on a lifelong career in this expanding industry. Students can participate in a hands-on demonstration of sheet metal assembler/riveter and composites labs and aerospace. Another flagship program is The Women in Aerospace Manufacturing (WAM) program which offers hands-on experiences to engage women in aerospace manufacturing. WAM is taught by women who have graduated from the pre-employment program and now work for Boeing. Recently, St. Louis Community College and The Boeing Company celebrated over 1,200 program participants hired through the program.

Becky Epps, Manager of the Center for Workforce Innovation at St. Louis Community College, and the individual who nominated Mr. Stroot for the Innovative ATC Workforce Development award said, "Dan's tireless passion for this program is a huge factor in its success."
